Following the recent DWP announcement confirming that a number of staging deadlines have been reduced – with 31 months of onboarding being compressed into just 18 months – we're urging firms to advance their readiness and connection journeys.

Step one:

Step three:

Then, our central onboarding team will support you configure the software, and test and confirm the connection between all services in the PDP's ecosystem.

Step five:

The fifth and final step to your solution is going live. Just before you do, we may have to gain Service Acceptance from the PDP, depending on the latest regulatory requirements. And then you're ready to connect.
